For this reason, we have implemented, and request you assist us with the following:

Please provide an active email address.

This will allow us to have a rapid means to contact you with pertinent information regarding appointments and scheduling. Most email is unsecure and for this reason we ask that when you respond to, or send an email to our doctors, that you do not send details of symptoms in the email. Please leave a phone number rand convenient time to talk, and your Dr will get to you as soon as possible. By providing an active email address you consent to Family Foot Care, PLLC contacting you via email.

Participate in Telemed, real-time, audio-visual office visits.

In lieu of a physical office visit, many conditions and follow-up appointments can be performed via audio visual consultation. We use **Doxy.me**, a secure HIPAA compliant, cloud-based interface for these encounters. You will need internet access and a smartphone, tablet or laptop computer. If you do not have access to this technology, chances are a child, grandchild or friend does. Please ask for their assistance. Please note, Telemed visits will be billed as office visits through your insurance. **New patients are always welcome!**

If our Dr feels your condition requires hands-on treatment, he/she will advise you appropriately, inclusive of having you come in for a physical office visit. During this emergency, Facetime, texting and other unsecure measures can be used if needed.
